RELEASE, WAIVER, AND ASSUMPTION OF RISK

Please Read Carefully

I, _____ hereby acknowledge and agree that in consideration of being permitted to participate in the Huck en Berries bike jam, organized and sanctioned by it organiser's

1. I do hereby release the, Huck en Berries bike jam's members, officers, directors, employees, independent contractors, land owners, volunteers and agents from all liability, and do hereby waive as against the Society, it's members, officers, directors, employees, independent contractors, land owners, volunteers and agents all recourses, proceedings, claims and causes of action on any kind whatsoever, in respect of all personal injuries or property losses which I may suffer arising out of or connected with my preparation for, or participation in, the Huck en Berries bike jam, notwithstanding that such injuries or losses may have been caused solely or partly be the negligence of the Organisers or any of it's members, officers, directors, employees, independent contractors, land owners, volunteers or agents,

2. And, I hereby acknowledge and agree: a) that the sport of mountain biking is very dangerous, exposing participants to many risks and hazards, some of which are inherent to the very nature of the sport itself, others which result from human error and negligence on the part of the persons involved in preparing, organizing and staging the Huck en Berries bike jam ; b) that, as a result of the aforesaid risks and hazards, I as a participant may suffer serious personal injury, even death, as well as property loss; c) that some of the aforesaid risks and hazards are foreseeable, but others are not; d) that I nevertheless freely and voluntarily assume all the aforesaid risks and hazards, and that accordingly, my preparation for, and participation in the Huck en Berries bike jam shall be entirely at my own risk; e) that I understand that neither the organisers nor any of their members, officers, directors, employees, independent contractors, land owners, volunteers or agents assume any responsibility whatsoever for my safety during the course of my preparation for or participation in the Huck en Berries bike jam; f) that I have carefully read this **RELEASE, WAIVER, AND ASSUMPTION OF RISK** agreement, that I fully understand same, and that I am freely and voluntarily executing same; g) that I understand clearly that by signing this release I will be forever prevented from suing or otherwise claiming against the organisers it's members, officers, directors, employees, independent contractors, land owners, volunteers and agents for any loss or damage connected with any property loss or personal injury that I may sustain while participating in or preparing for the Huck en Berries bike jam whether or not such loss or injury is caused solely or partly by the NEGLIGENCE of the organisers or any of it's members, officers, directors, employees, independent contractors, land owners, volunteers and agents; h) that this **RELEASE, WAIVER, AND ASSUMPTION OF RISK** agreement is binding on myself, my heirs, my executors, administrators, personal representatives and assigns.
